**Explanation of Responses:**

- The restrictions on such restricted stock units shall lapse 100% on July 29, 2022 if the Company's cumulative non-GAAP diluted earnings per share growth during the 36 month period ending on the last day of the Company's fiscal year 2022 equals or exceeds a 3% cumulative compound annual growth rate, as determined by the Compensation Committee.

- These options become exercisable at the rate of 25% of the shares granted per year beginning on the first anniversary of grant.
