- The number of shares to be issued in connection with the performance share units ("PSUs") will vary depending on the level of certain performance metrics achieved over a three (3) year performance period. If target performance metrics are achieved, 51,758 shares will be issued. The actual number of shares to be issued could range from a low of 10,352 at minimum performance to a high of 103,516 shares at maximum performance. If minimum performance metrics are not met, such PSUs may vest at 0 shares.
- Vests on August 3, 2023.
