**Explanation of Responses:**

- Each performance share unit represents a contingent right to receive one share of Medtronic common stock.
- The number of shares to be issued in connection with the performance share units ("PSUs") will vary depending on the level of certain performance metrics achieved over a three (3) year performance period. If target performance metrics are achieved, 10,582 shares will be issued. The actual number of shares to be issued could range from a low of 2,117 at minimum performance to a high of 21,164 shares at maximum performance. If minimum performance metrics are not met, such PSUs may vest at 0 shares.
- Vests on August 3, 2023.
